## Class of 2009 Senior Grad Night Student Behavior Agreement

I understand that attending the Grad Night is a privilege and **I agree to the following:**

1. Party hours are from 8:30p.m., June 11 to 5:30 a.m. June 12, 2009. Buses will be boarded promptly at 8:30p.m.
2. No student who is under the influence of alcohol or drugs will be admitted or allowed to board the bus. If I am suspected of being under the influence of a controlled substance either before boarding the bus or any time during Grad Night, my parents will be called to pick me up. I will not be allowed to return and I will not get a refund for my bid.
3. All parent/adult volunteers are donating their time and effort so that my classmates and I can have a fantastic time. I will treat them with respect.
4. Many parents have spent an entire school year working to put this party together. I will show my appreciation by not damaging the facility, games, decorations, etc.
5. I will show respect for my fellow students, as well as the volunteers, by not using inappropriate
